Houseparty

Online Safety Newsletter

Houseparty

This month, Houseparty is in the top 5 of free apps on the App store. Houseparty is a face to face (video) social network available as either an app or web version. The App store rate it as 12+, however no age verification takes place when you set up an account.

What is Houseparty?

It allows you to video chat with other users (your connections) as well as play in app quizzes and games with each other, it's designed to feel like a house party hence the name! Up to 8 people can join each room and you can join a number of rooms at any one time by swiping across.

How to lock rooms:

Once you have set up an account, you access the main interface of the app where you can set up/join video chats with users you are connected to (these are called connections). Once you are in a video chat (room), your connections and their connections are able to join the same video chat session regardless of whether you invite them or not **unless** you lock the room. So, if you do not lock the room, then a friend of one of your friends can join that video session. If somebody that isn't your connection is about to join then you will receive a notice that they are joining the session. We would recommend locking the room by simply tapping on the padlock at the bottom of the screen once everybody that you want is in the room/joined the session.

If you enable privacy mode then every room you go into will automatically be locked. To do this, tap on the smiley face and then tap on the settings cog. Next tap the 'privacy mode' to toggle on and then select 'enable privacy mode.'

Permissions

Tap the smiley face, tap the settings cog and then tap permissions to reach the Permissions menu. Here you can simply tick each item as on or off as you choose. We would definitely recommend **not** enabling location.

Reporting

As with all apps, it's important that your child knows how to use the reporting tools within it. You can report direct to Houseparty if you see any inappropriate behaviour by shaking the app when in it and following the instructions. You can also un-friend or block a person by clicking on their profile, tapping the settings cog and choosing to 'unfriend' or 'block/report.'

What you need to be aware of

- In-app purchases: One feature of Houseparty is the ability to play games and quizzes with your friends. Some are free and some can cost £0.89 - £4.59 per item.
- Content: Other users may take screenshots/recordings of your private chats without you even realising
 and there is also the potential to see inappropriate content (from your friends/friends of friends).
- Strangers: your child may come into contact with people they don't know (friends of friends).
- Notifications: when you open the app, you friends will receive a notification to tell them and also you
 will receive a notification when your friends open Houseparty. Notifications can be switched off in
 settings (tap smiley face, tap 'manage notifications' and disable).



As always, have regular chats with your child about what they are doing online and also join in so you can see for yourselves. It's really important to make sure that your child knows that they should talk to you or another trusted adult if they have any concerns.

Snapchat

Snapchat is a messaging app used to send photos, videos, text and drawings (called snaps) which disappear after they've been viewed. You should be 13+ to sign up. If you choose to allow your child to have an account then you should be aware of the following:

Snap Map (sharing their location)

The Map lets users see where their friends are if a friend has chosen to share their location at any given time. Location sharing with friends via the map is optional and is off by default (we recommend that this remains the default setting).

Snapchat streaks

Streaks count how many consecutive days two people have been sending Snaps to each other. A streak is shown by a little picture of a flame and a number (the number of days the streaks has gone on for) next to a contact's name. There can be pressure to respond on a daily basis to maintain their streaks and it can cause issues with people logging into other's account to carry on streaks for friends.

Reporting

Ensure your child knows how to report any issues when using Snapchat.

Safety tips and resources

It's really important to talk to your child regularly and make sure that they know that you're always there to talk to if they have any concerns.

TikTok update

What is TikTok?

Users can watch musical clips, record (up to) 60 second clips, edit them and add special effects.

Is your child old enough?

You must be over 13 years of age to use TikTok

Why should I be concerned?

Some of the songs used in this app may contain explicit language and sexual imagery, which may not be suitable for your child to view.

If your child is using TikTok then we recommend setting the account as private. Internet matters explains how to here: <u>https://www.internetmatters.org/parental-controls/social-media/tiktok-</u> privacy-and-safety-settings/

Did you know?

Even with a private account, your child's profile information such as their photo and bio is still visible so ensure your child understands the importance of not adding personal information (e.g. address, age and phone numbers).

Talk to your child

Why does your child use it? What do they like about it? Do they know their followers? What do they like watching on it? Have they ever seen anything that has worried them?

Family safety mode



YouTube Parent Question

What should I do if my child wants to upload videos on YouTube?

The decision obviously lies with you as the parent and regardless of your decision, it is really important that you maintain an open conversation. If you choose not to let your child post videos on YouTube then explain why, if you agree, then set some ground rules such as comments must be switched off, the channel must be kept private and of course monitor what they are uploading.



Fortnite

Sectoria is rated PEGI 12 for frequent mild violence which means it is not suitable for persons under 12 years of age to play. PEGI do not take into consideration the chat features when rating games. Sectorie contains voice and text chat, which can contain inappropriate and explicit language. You can turn the voice chat off but not the text chat. As always, show your child how to report players for any inappropriate behavious (more information can be found here: https://epicgames.helpshift.com/a/fort nite/} and ensure that they know that they should talk to you or another trusted adult if they have any concerns.

In app purchases:

All users can purchase V-Bucks directly through the game so make sure you don't store your credit card details and your child understands that they must check with you before making any purchases.

We always recommend playing the game with your child so you can see what they are playing and monitor the sort of chat that they are listening/contributing to.
